Institutional Investment Approach

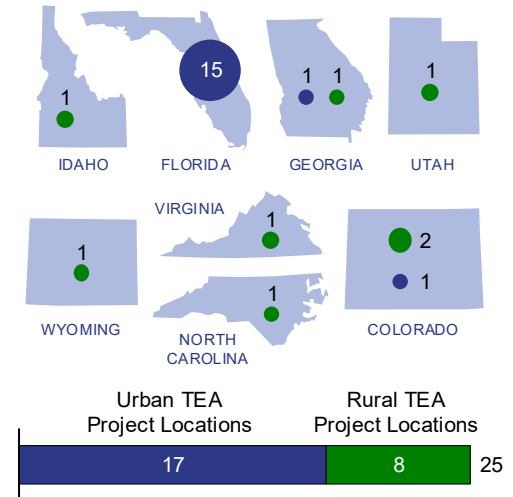
EB5AN's approach is to identify institutional-quality real estate development projects that satisfy its strict internal underwriting criteria for both immigration and financial risk.

EB5AN managed projects are structured to not be reliant on any minimum amount of EB-5 funding to achieve completion. Additionally, EB5AN prioritizes investing in projects with EB-5 jobs already created for its investors, and those that are ultimately projected to create significantly more jobs per investor than are required under the EB-5 program.

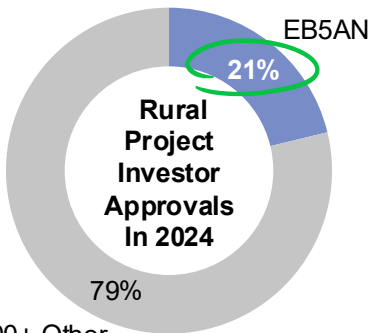
EB5AN's founders hold degrees from Yale, Stanford, and UNC Chapel Hill, and previously worked at some of the most prestigious investment and professional services firms including the Boston Consulting Group (BCG) and AEA Investors.

EB5AN collaborates with multiple top development firms including Kolter—one of the largest private developers in the country. Since 1997, Kolter has invested in projects with an expected value of over \$37 billion, completed over 100 residential projects, delivered over 29,000 units, and never failed to repay a loan.
